**INDEMNIFICATION AND HOLD HARMLESS NOTICE**

Please note for this waiver, the Regina Dragon Boat Festival Inc. and Dragon Boat Regina or the Regina Dragon Boat Club includes their respective directors, members, trustees, agents, representatives, officers, sponsors, licensors, servants, volunteers and employees.

1. In consideration for receiving permission to participate in the Regina Dragon Boat Festival Inc. and Dragon Boat Regina activities, the receipt of said permission being hereby acknowledged, I do hereby forever RELEASE any and all liability, discharge and agree not to sue the REGINA DRAGON BOAT FESTIVAL INC. and/or the Festival subsidiaries and agree to and save them HARMLESS AND INDEMNIFY them from and against any and all liabilities, claims, injuries, losses, damages, expenses, demands, actions, and causes of action of whatsoever kind or nature arising out of or related to any such loss, damage, or injury, including death, etc. that may be sustained by me for whatever reason while so participating in the RDBF activities and/or subsidiary Club whether such damages are the result of negligence or for any other reason or cause.

I also agree to discharge forthwith on request of the RDBF and their authorized representatives each and every obligation or claim which shall be made, assigned or apportioned against the RDBF and its subsidiary organizations and their respective directors, agents, members, trustees, representatives, officers, sponsors, licensors, servants, volunteers and employees by any party by virtue of any injury or damage caused by me or to me absolutely.

I and my next-of-kin are duly aware of the risks and hazards inherent in both the sport of paddling and entering the premises used for the purpose of launching, docking and storing equipment used in the sport of paddling, and specifically in participating in the Regina Dragon Boat Festival Inc. and/or subsidiary clubs and the practice sessions and participating in events, knowing conditions may be hazardous and dangerous and that obstructions may exist, and that high winds may cause rough water, and that I hereby give notice that I am a competent swimmer and/or will wear the personal floatation devices as required and that I voluntarily assume all risks of loss, damage or injury, including death, that may be sustained by me or to any property while engaged in said festival and club activities.
