

## TRADE MARKET VENDOR CONTRACT

This is an agreement between the Regina Dragon Boat Festival _(hereafter referred to as "RDBF") and

has iss	ued the Host a sum of \$_105.000 for a license to vend at the Event,	
The RD	BF and Vendor both agree to the following terms:	
<ol> <li>2.</li> </ol>	Vendor will be given access to the place that is agreed upon by both parties no less than <u>8</u> hours before the Event starts to set up the Vendor's station, goods to be sold, and anything else that is needed and customary to vend at that specific location.  The Vendor will not sell any items or services that are not disclosed here at the Event without prior written consent from the RDBF or the Market Organizer.	
	Items that will be sold:	
3.	Vendor's stations will be be limited to 10x10 tents (notent spikes are permitted on pavement); and shall be clean and orderly; and shall follow all applicable laws and regulations of the RDBF, Wascana Park Authority, City of Regina and Province of SK; including all Covid Protocols as set out by SHA and the Province of SK and City of Regina	
4.	Vendor's staff may exhibit that goods are for sale only while the staff is within the area of the vendor's specified location.	
5.	Vendor's staff will be properly dressed and their appearance will be clean and neat and they shall conduct themselves in an orderly fashion.	
6.	There is to be no loud distracting music, noise, and or sound amplification devices used by Vendor's staff at the Event, without permission of the Market Organizer and the RDBF. All licensing and copyright laws will apply	
7.	Vendor will have access to the location for up to <u>4</u> hours following the Event has concluded at <u>6</u> :00 PM AM / PM to dismantle and remove all items brought to the Event by Vendor. Vendor shall leave the location free from trash and in similar condition that it was in before the Vendor was there.	
8.	Vendor agrees to hold the RDBF and its agents free from any damages or claims that may develop in connection with participating in the above mentioned Event.	

9.	All vendors will supply their own power, water, and all other requirements necessary to operate their unit.
10.	Boards must secure all hitches, tires and generators if the vehicle or unit is not operating on pavement
